1. Background of the Assignment

I.I Introduction

'Nobo Jatra, a five-year USAID Food for Peace Title II Development Food Aid Project commenced in September 2015 and will come to end in September 2020. Led by World Vision Bangladesh (WVB), Nobo Jatra is a shared commitment with World Food Programme (WFP) and Winrock International (WI) as sub grantees and is implemented in partnership with the Ministry of Disaster Management and Relief (MoDMR) of the Government of Bangladesh. Project implementation is in the south west coastal areas of Bangladesh, in four Upazilas (sub districts) under two districts; Dacope and Koyra in Khulna; Shyamnagar and Kaliganj in Shatkhira covering 856,116 direct beneficiaries.

The goal of Nobo Jatra program (NJP) is to improve gender equitable food security, nutrition and resilience of vulnerable people in Bangladesh. Thus, gender is a cross-cutting mechanism through all the components of the program. Through this, women are being able to better exercise their choice, negotiate for their rights and improve social/family structure through active participation. Some of the important segments of the gender component of NJP are: Men Care groups, life skills training, leadership skills, and awareness raising of young girls of their roles within the family as well as making them and their families aware of the consequences of **early marriage**.

1.2 Campaign to reduce Early Marriage:

To influence reductions in early marriage and concomitant reductions in adolescent pregnancy, Nobo Jatra Project is transforming the attitudes and practices surrounding early marriage, especially among influential groups, including religious leaders, birth attendants, fathers and mothers-in-law with awareness and behavior change campaigns. The campaign initiated SBCC interventions included dedicated radio spots, theater performances, billboards and distribution of other materials (e.g., stickers and leaflets). In particular, SBCC messaging has tailored to reach multiple audiences, including fathers and grandmothers (as key influencing groups and decision makers), as well as mothers and adolescent girls and boys. Nobo Jatra project also is working for the Engagement and sensitization of other influential group and Child Protection Committees (CPC) to report and prevent cases of early marriage.

3. Expected Deliverables

- Script for community theatre on early marriage in consultation and collaboration with gender team of NJP and Shushilan.
 - Nobo Jatra technical team will review the script and provide necessary feedback.













- ----Facilitate training for theater performers group
- Follow up one community performance in each Upazila and provide support to ensure quality

4. Contents of the Script

- a) Highlight major cause of child marriage and the consequences of child marriage in a girl's life
- b) Showcase the vulnerability of women in different contexts (gender discrimination, social and cultural norms, taboos). It should be focused on challenges and opportunities of women in terms of dignity, rights, entitlements, health, income, and leadership.
- c) It should also highlight the law and policies against child marriage and role of relevant stockholders
- d) The script will feature:
 - Impact happened through early marriage in the community
 - Consequences/penalties of early marriage in Bangladesh

5. Time Frame

The individual/ organization will be engaged for 24 working days after signing the agreement. The script must be finalized by 31 March 2019 by addressing all the feedback from the client. For the assignment following time frame will be followed.
