Background

Max Foundation (MF) aims to prevent child mortality in a most efficient and effective way. MF believes that charity profits from a business-driven approach. At Max Foundation we work with our heart and our head in order to maximise our impact: saving as many children's lives as possible. MF is a fast growing and innovative INGO and currently looking an academic institution/academic to conduct a field research to identify the locality and context specific determinants and risk factors association with child stunting. The study will carry out in the six-selected study area unions from Khulna, Sunamganj, Satkhira, Patuakhali, Kurigram and Madaripur.

Objectives of this assignment

- 1. Conduct a research to identify the causes of stunting among the U5 children and find out the association of stunting with WASH, SRHR, Nutrition and governance considering the local determinants in the selected areas of Patuakhali, Barguna, Khulna, Satkhira, Jessore, Madaripur, and Kurigram in Bangladesh.
- **2.** To recommend the best combination of interventions in the similar rural and urban context for Max Foundation.

Scope of Work

The assignment holder is expected to undertake the following task to deliver on the objectives

- Design of the research method and hypothesis in line with the research objectives;
- Propose a relevant data collection strategy, such as sampling strategy, sample size, and household survey;
- Write a study protocol clearly describing all steps of the research;



- Provide technical expertise in developing and training data collectors in the procedures on collection of quantitative and qualitative data through measurements, interviews and focus group discussions;
- Perform statistical analysis of the quantitative data;
- Perform analysis of qualitative data and interpret the results of qualitative and quantitative research (triangulation);
- The assignment must flexible if any new ideas and thoughts and adjustment;
- Before finalizing the report, the assignment holder will organise a national level sharing report and incorporate the expert opinion;
- The methodology will be used to conduct the study must accepted by the sector experts.

Approach/methodology

- Before/after intervention study design including mixed research methods (quantitative and qualitative research methods).
- Linkage between internal M&E and baseline-end line evaluation.
- Full methodology will be described in the research protocol.

Deliverables

• A full report of the study including the raw data and full list of local and context specific determinants;
