TERMS OF REFERENCES

Assess current status and constraints of rights and entitlements situation of marginalized and poor communities in selected remote locations of Bangladesh

1. Introduction

The Resilience through Economic Empowerment, Climate Adaptation, Leadership and Learning (hereafter known as REE-CALL) project is intervening to build the resilient communities in disaster prone Northern Char, Haor and Southern Coastal communities linked with the urban disaster. The REE-CALL has been implementing in selected locations are highly exposed to extreme weather event or natural disaster since 2011. Project location are at 14 districts within three agro ecological zones likewise river island, wetland and coastal being implementing through local implementing organizations. The aim of REE-CALL is to develop leadership through economic empowerment, disaster risk reduction and climate change adaptation, establishing rights and entitlements into public essential services so that community become resilience to thrive against all climatic and non-climatic shocks. Inclusive Community Based Organization-CBO is the main hub to steer all development interventions of the project.

2. Rational and specific objectives of the study

One of the major interventions thrust in REE-CALL project is to promote rights & entitlements of poor and marginal peoples in line with constitutional provisions, legal and policy framework and provision. Being in to this, the project mobilized to form Community Based Organization (CBO) as collective social platform use to create common understanding & awareness on rights and entitlement for access to resources & services and emerging as right holder entity at local level. In order to bring greater coherence and cohesion within community through formation of CBO alliance, Resilience Action Groups, inclusion in local decision making process, building leadership capacity, governance performance monitoring etc. put in action as endeavour to enjoy citizen's rights & entitlements. Over the period, the project achievements reached a substantive level and many good practice with local champions identified who contributed in overall project goal. The major objective of commissioning this study to assess progress & challenges of promoting rights & entitlements of poor marginalized community in selected project locations and identify actions to address the challenges given opportunity of Oxfam work in Bangladesh.

This study will help Oxfam to understand following issue but not limited to:

- Find out major aspects of peoples' rights and entitlements in context of state and government commitments
- Explore extent & effective involvement of poor people's into local power structures and its impacts on their lives in disaster affected locations
- Explore existing opportunities and challenges for poor people to enjoy rights and entitlement as citizen of Bangladesh
- Identify expected roles & action of respective stakeholders including national and local government, development agencies and CSOs.

3. Scope of Work

- Discussion with Oxfam team and partner staff members to understand the project objectives and the role, status
 of different IGA and different economic empowerment activities within REE-CALL project
- Compiled the rights and entitlements options and scopes of the respective community from the existing policy, plan and intervention documents.
- Assess the state of rights and entitlement context currently practiced and followed in the community.
- Discuss with project beneficiaries, relevant stakeholders both at field and central level for the above mentioned information.
- Propose recommendations to way forward along with a strategic directions for further interventions

4. Key Responsibilities of the Consultant

- Review relevant documents received from Oxfam and also consulted relevant documents
- Consult with Oxfam and partner staff to understand the designed project framework , implementation process, approaches and relevant information
- Review the documents related to government economic opportunities particularly designed for women, vulnerable and marginalized groups
- Field visit in selected locations to understand the project nature, understand the capacity of the community based organizations and staff members

 Documenting the current status, key success and challenges including constrain and devising recommendations to way forward.

Oxfam will facilitate and support the consultant for the work while required. These include:

- Provide relevant project documents
- Communicate with respective partner organizations and share the field engagement plan
- Share the secondary information/data/documents related to the assignment
- Provide necessary feedback/comments on proposed tools, plan and methodology
- Provide feedback on enumerators' orientation plan (if involved for FGDs and KII)
- Regular monitoring on progress of study
- Feedback on draft report.

5. Timeline & location

- The study will take place during August & September 2015 and consultancy period would be maximum 30 days
 including preparation, local travel, data collection, draft submission, incorporating the feedbacks and final report writing
- The study location will be selected Upazillas of Pirojpur, Kishorgonj & Nilphamari but location may changeable based on discussion.

6. Deliverable

- An inception report including methodology, information collection plan, reporting outline and time table within five days of commencing study work
- A draft report including key findings and recommendations for comments to Oxfam.
- The report must include an executive summary (covering the key issues and findings maximum 3 pages excluding annexes), main body with recommendations of maximum 25-30 pages
- The Final report should be submitted within 5 days after receiving the comments. Additionally the consultant will submit Bangla script of executive summary of the report (max. 3 pages) and deck of max. 15-20 slide in power point along with final report.

7. Evaluation

In response to the invitation, the individual consultant/consulting firm will have to submit a Technical and Financial proposal as per this 'Terms of Reference'. The total scoring points for both the evaluations will be **100**.

A cumulative analysis weighted-scoring method will be applied to evaluate the firm. The award of the contract will be made to the consultant/consulting firm whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable with reference to this ToR, and;
- Having received the highest score out of a pre-determined set of weighted.
