

TERMS OF REFERENCE (TOR) ON STUDY ON COMPRESSED BIO GAS IN BANGLADESH

1. About Oxfam:

Oxfam is an international confederation of 20 organizations networked together in more than 90 countries, as part of a global movement for change, to build a future free from the injustice of poverty. Oxfam believes that all people are rights-holders and that human rights apply to all people equally; and that all duty-bearers, especially states, have an obligation to respect, protect, and fulfil these human rights.

2. Rational & Background:

"Enterprise Development Programme (EDP)" is an unique impact investment prgramme lead by Oxfam in Bangladesh under the Economic Justice and Resilience¹ Pillar. A number of small projects is running since 2017. The concept of EDP is different from regular development project funded by Oxfam.

Bangladesh is a role model in the world for micro finance and done a great job. Whilst microfinance offers great opportunities, evidence suggests that it is not the most effective way to reduce poverty and drive economic growth in the long-run. One of the important aspects of Bangladesh's recent economic resilience and progress is a flourishing rural economy, covering both agricultural and non-agricultural activities including enterprise development. It is widely recognized that the development of Micro, Small and Medium Enterprises (MSMEs) is essential for overall economic development of a Bangladesh. MSME sector has a great role to achieve the government declared "vision- 2021" as well as sustain Development Goal (SDG). But due to lot of financial & non-financial barriers MSME sectors cannot flourish as it's expected.

Based on this recognition, Oxfam in Bangladesh has operating its unique impact investment activities for developing the rural based MSME in Bangladesh under the Enterprise Development Programme's (EDP) and its objectives to provide various financial & non-financial supports to rural small & growing enterprises that enables them to become sustainable businesses and benefit for smallholder farmers and women:

EDP in principle focuses on the agricultural, food and rural sectors, but is open to analyses other sectors. EDP helps promising businesses to reach SME size, so they can grow more easily, ensure market access for thousands of farmers while also achieving economies of scale.

In view of Oxfam in Bangladesh under its EDP is going to conduct a field study to know the current landscape of Compressed Bio Gas(CBCG) in Bangladesh. The landscape in terms of;

- a. Country current demand and utilization pattern of Gas sector (both cooking, household and commercial level & CNG-as fueling) and supply of sources of Gas.
- b. Current source of compressed natural (CNG) and bio gas, compressed bio-gas and opportunity to use CBG as an alternative source of gas

- c. backward and forward market opportunities of major types of Bio gas like vermicomposting and organic farming
- d. commercial use of the alternative source of gas by using in cylinder for cooking and transportation,
- e. safety net (health, environment and climate) by using the gas in cylinder and opportunities and challenges of CBG in Bangladesh
- f. Current market actors of the gas (cylinder gas) and their source and demand supply status;
- g. The challenges and prospects to use cow dung, kitchen and hotel waste as raw material to produce compressed bio-gas.,

3. Objective of the Assignment:

The aim of the Consultancy is to conduct a **qualitative and quantitative** study on natural gas, bio-gas & compress bio gas(CBG) situation in Bangladesh.

- 1. Conduct a qualitative and study on natural gas, bio-gas and compressed bio gas (in cylinder and gas station) situation in Bangladesh.
- 2. Market review and research on compressed bio gas by using cow dung and kitchen waste and their other backward and forward market opportunities.
- 3. Commercial and business feasibility analysis of the cylinder based bio gas in the household and market.

4. Scope of the Assignment:

- **4.1** The consultancy will be based on secondary review, interview and market assessment.
- **4.2** The consultant will work closely with all relevant actors (Bangladesh Petroleum Corporation, University, researchers, academicians, Chamber of commerce, Associations, Gov't and autonomous body) of Gas, Power, CBG and Oxfam in Bangladesh EDP team to ensure and validate information and process.

5. Key Tasks:

- **5.1** Desk review on the necessary documents which is relevant to Natural gas, Bio-Gas, CBG and CNG
- 5.2 Interview with the relevant actors related with Gas, Bio-Gas and CBG
- 5.3 Identify and collect all existing market actors of CBG
- 5.4 Identify and analysis the scope and opportunity of the domestic market in divisional wise for CBG
- **5.5** Find out the key Challenges in all respects like technological, legal, business environment and scope of CBG (from cow dung and kitchen waste) in Bangladesh.
- **5.6** Key challenge to produce in community base electric facility by using CBG or bio gas and its potential opportunity in terms of market demand.

The consultant will be expected to work with many of the stakeholders in relation with Gas sector, throughout the country.

9. Qualification and Experiences of the consultant:

A team (gender balanced) made up of at least: - A lead consultant with sufficient skill, research experience and a graduate or post graduate in relevant discipline like power engineering, environment technology, Industrial engineering, Business process and designing or equivalent degree in dairy science or dairy waste management and business discipline. Adequate no's of supporting researchers with at least five years' professional experiences in relevant fields like market research, environmental research, business process design, mapping, Power sector particularly in Gas sector, Dairy plant etc.





- **9.1** Demonstrated experiences and skills in facilitating stakeholder/working group consultations.
- 9.2 Demonstrated knowledge and experience in market research.
- 9.3 Have capacity to work within the deadlines.

10. Evaluation and selection process:

Interested consultancy firm are requested to submit a technical and financial proposal for the work following ToR on conducting study on Gas, Bio-Gas, CNG and CBG. Applications will be considered those are top most suitable, relevant and apply within the mentioned time.

• The evaluation team will fully reportable to Enterprise Development and Private Sector Coordinator, Oxfam in Bangladesh. She/he will also work closely with relevant staff of EDP team

10.1 Evaluation process
