1. BACKGROUND AND RATIONALE

Under the pillar of Economic Justice and Resilience, Oxfam in Bangladesh is implementing the Empower Youth for Work (EYW) Project. It is a 5-year project being funded by IKEA Foundation and implemented in Bangladesh, Pakistan, Indonesia and Ethiopia. The overall aim of the EYW programme in Bangladesh is improved economic and social empowerment for young women and men living in rural climate-change affected areas.

The target group of the project consists of young women and men, community members, policy makers, government representatives and private sectors actors. The main target group is young women and men of aged 15-29 residing in rural climate vulnerable areas. An estimated 40% of the youth population in this age group is not in the labour force of the country. 74% of youth not in the labour force is female; these women are primarily engaged in unpaid household level care work. The geographic locations of the project are: Mithapukur upzilla under Rangpur district, Puthia upzilla under Rajshahi district, Botiaghata upzilla under Khulna district and Bakerganj upzilla under Barisal district.

The project aims to provide support to 67,000 direct beneficiaries, focusing on women from targeted townships and communities in Bangladesh to improve their economic and social resilience to climate extremes. The project is aims to empower 70% female youths of the project areas. To improve the situation of women empowerment it is necessary to address inequality and promote women's empowerment. Therefore, it is crucial to understand the root barriers of women's active participation in socio-economic activities, especially their unpaid care work status and its impacts over women's life. Apart from the social aspects, environment as well as climate also act as drivers of vulnerability for the different rural people and social groups. The resulting vulnerability and uncertainty of both social and environmental changes as well as the existing care work pattern of the society differently affect community, individuals especially women. Therefore, Rapid Care Analysis and Vulnerability and Risk Assessment are important for uncovering less-understood barriers to women's and girls' participation in our programmes, and the context of landscapes and drivers of communities and stakeholders respectively.

2. OVERALL OBJECTIVE OF THE STUDY

The aim of this study is to generate information and insight which can be incorporated into project planning and create enabling environment towards more resilient and equal society through action research using two participatory methodologies- Rapid Care Analysis (RCA) and Vulnerability Risk

Assessment (VRA) The information and findings from the Rapid Care Analysis and Vulnerability risk analysis will be used to explore the solution and preferable strategies to recognize, reduce and redistribute the unpaid care work of the women living in vulnerable areas and create a resilient community.

3. SPECIFIC OBJECTIVES OF THE STUDY

The specific objectives of the study are but not limited to -

- To gather evidence of care work, unpaid and paid work activities performed by women and men in the household and community level. Specifically, information about the time engagement, gender and age distribution of care activities as well as available support, services, infrastructure around care work.
- To document the existing condition of social norms and perceptions about gender roles and about care work and suggest some innovative interventions and measures for reducing, recognizing and redistributing care work.
- To gather evidence on natural disasters, climate change impact on livelihood of people and identify
 how work distribution, mobility, economic activities and constructions of reality are affected in a
 changed environment.
- Identify the area based and community based vulnerability and capacity of the community people and develop a risk reduction plan.
- Identify and explore the gendered impact of climate change and how CC impacts shape and constrain people's social norms and participation on woman.
- Recommend some ideas with a mixture of existing and new materials to sensitize and influence communities about household workload sharing and investments in labour- and time-saving equipment to reduce workload.
- Identify some issues for advocacy with institutions or government based on the finding. An analysis
 of the of the effectiveness of the methodologies used-their strengths, weaknesses and how each
 complement the other to provide a clear and accurate representation of the inside workings of
 household economies at different levels of a wealth continuum.

4. PROPOSED /EXPECTED METHODOLOGY

The consultant will develop in detail the most appropriate methodology for undertaking the action research effectively ensuring high quality, practical and useful results as stated in this TOR. The consultant will make use of two primary participatory tools and methodologies-Rapid Care Analysis (RCA) and Vulnerability Risk Assessment (VRA). The consultant is encouraged to make use of additional methodologies, including Household Economy Approach and Time Diaries to complement RCA and VRA techniques. The consultant is also expected to ensure maximum community involvement, particularly of

the targeted beneficiaries. The consultant will also apply a gender responsive approach to all aspects of the work.
