

TOR FOR DEVELOPING MODULES AND CONDUCTING TRAINING TO FISH NURSERY OWNER & PATIL PATI OF CHETONA FISH HATCHARY IN KURIGRAM

1. About Oxfam:

2. Rational & Background:

"Enterprise Development Programme (EDP) - Bangladesh" is a unique Impact investment programme led by Oxfam in Bangladesh under the Economic Justice and Resilience¹ Pillar. A number of small & Growing business enterprise/ projects is running since 2017. The concept of EDP is different from regular development project funded by Oxfam. Usually, Oxfam implement the project through its local level implementing partner, but EDP programme is directly work with different rural based Small and Growing enterprises, where, EDP provides different technical support to develop the capacity of the selected enterprises in terms of quality, quantity and sustainability and institutionalize the enterprise through strengthening its finance, administration, Inventory management, business operation and management. By 2018, there are four enterprises were selected and approved under EDP, among them one is Chetona Fish Hatchery situated in Rajarhat, Kurigram.

Chetona Fish Hatchery situated at, village-Chetona, Union-Gharialdanga, Thana-Rajarhat, District-Kurigram. Mr. Ishaq Ahmed has established this enterprise in 1998, currently it sells 12 varieties of fish spawn to 30 permanent fish nursery owner, fish farmers and traders in the Kurigram district. There is a large demand for high quality as well as indigenous varieties of spawn in the local and regional market. Chetona Fish Hatchery, the current market leader in the region, has a noteworthy reputation in the community as well as demonstrable know how and technical capacity and is therefore well positioned to further increase its market share by introducing new fish varieties and expanding its client base. The enterprise currently employs 5 full time staff including the Manager cum CEO Mr. Ishaq. The assistant manager manages the overall day to day operation. The pump operator mainly responsible for water management and another person mainly supports administrative activities of the business. Additionally, during the production period 5 to 10 more employees are hired on a temporary basis.

3. Objective of the Assignment:

Under the EDP, Oxfam in Bangladesh is going to provide some technical support and knowledge on fish farming, fish nursery management and so on to the enterprise as well as to the fish farmer linked with the respective enterprise. This support will help to increase the production of the hatchery.

So, the main objective of the Consultancy service is to develop different training module and provide training based on the module to the selected fish nursery owner and fingerling traders (*patil patil*. This assignment will focus on the increase of production of the fingerling traders (*patil patil*, capacity development on nursery management, entrepreneurship development and business development of the fish farmers especially women fish farmers. Apart from production increase the training design should also focus on the increasing women's participation in the fish nursery business, women's economic empowerment.

The objectives of the assignment are to develop module and conduct training on some specific issues and also use the local resources and resource persons. This will comprise:

- 1. Review the existing module of different department of Government, INGOs and develop different training module on
- 1.1 Fish Hatchery- increase the Production and decrease the mortality rate of fish
- 1.2 Fish Nursery management
- 1.3 Entrepreneurship development and business capacity development of fish nursery owner
- 1.4 Fingerling Management of Patil Pati.
- Arrange and conduct different training based on the module in Kurigram by using local resources and resource persons.

4. Key Tasks:

- **4.1** Identify, collocate and review of all relevant existing training module of Government, NGOs, INGOs and recognized training institutions.
- **4.2 Need Assessment** of Training and content development will be conduct before designing the module for each training and field test also performed by the consultancy group.
- **4.3** For increasing the fish production and reduction the mortality rate training to *patil party* and fish nursery owner is very crucial. So, the training module should focus on increase the production and decrease the mortality rate.
- **4.4** Apart from production how the nursery will be managed also need to cover during the assignment.
- **4.5** The assignment also focus on the entrepreneurship development and business development of the fish nursey owner especially women.
- 4.6 All the module should develop in Bangla
- 4.7 Facilitate each training and conduct pre and post assessment of each training will include.



4.8 Use the local resources and local resource persons.

6. Duration of the Assignment:

The expected duration of the assignment is based on the deliverables module development and training starts from July to August 2018.

7. Location of the Assignment:

The consultant will be expected to work with many of the stakeholders in Kurigram District, Ministry of Fisheries and Livestock, Agriculture University and different training institutions of Bangladesh.

8. Qualification and Experiences of the consultant:

A team made up of at least: - A lead consultant with a post graduate or equivalent degree or expert on concern economic sector or sub sector expert on <u>Fish spawn production</u>, <u>hatchery management</u>, <u>fish farming</u> with having minimum 10 years of professional experience with required no's of team member. Expert on module development and 5 years' experience as trainer. Ensure the gender diversity in team <u>And need base add the member from local resources:</u>

- **8.1** At least 5 years of prior professional work experience in dealing with fish farming and fish management or relevant nature of works will be an added advantage
- **8.2** 5 years' experience as trainer and module development.
- 8.3 Knowledge and experience to work with small holder farmers and small enterprise.
- 8.4 Proven ability and experience in leading and facilitating different training.
- 8.5 Excellent communication skills for discussing issues with all manner of persons
- 8.6 Have capacity to work under tight deadlines.

9. Evaluation and selection process:

Interested consultancy firm or <u>individual requires</u> submitting a technical and financial proposal for the work following ToR of module development and conducting training. Applications will be considered those are most relevant qualification, experience and apply within the mentioned time.
