# Terms of Reference (ToR) for Agency Hiring For conducting an Impact Study on Community led Child marriage free village Campaign World Vision Bangladesh

Purpose of the assignment	For conducting an Impact Study in 158 Child marriage free villages within World Vision Bangladesh (WVB) working area (Village list will be added later on)
Overview:	Child marriage is one of the most pressing issues. In Bangladesh, that violates the rights of children and has severe consequences for their physical, psychological, and social well-being. Bangladesh witnessed an increasing rate of child marriage during COVID 19. Considering the emerging situation World Vision Bangladesh, in collaboration with the National Human Rights Commission Bangladesh (NHRCB), is implementing a country-wide campaign called "Child Marriage Free Village" to prevent child marriage across the program area.  WVB in collaboration with NHRCB is going to celebrate the success through a national-level symposium aiming country wide awareness building, so that every village can be declared as child marriage free village and as a result Bangladesh would celebrate as Child Marriage Free country.
Study Objectives:	World Vision Bangladesh in collaboration with National Human Rights Commission was facilitating a community led campaign called "Declare Child Marriage Free Village". Government authorities like Minister, MP, NHRC, DC, UNO, Upazila Chairman & Union Chairman (area to area have variation) declared 158 villages as child marriage free in 2023 and 2024.  So, the key objective of the Small Study/Assessment is to capture and showcase field experience, successful strategies and success of the Community led Child Marriage free campaign to the external stakeholders along with key policy makers. So that the report can inspire key decision makers to take necessary actions to eradicate child marriage from the society.

#### **About World Vision:**

World Vision is one of the largest international, a Christian humanitarian development and advocacy organization, committed to helping children and families in poor communities improve their lives and alleviate poverty.

# **Methodologies:**

# Data-gathering will include Qualitative method.

A standardized set questionnaire will be applied to collect quantitative and qualitative data from the sample. Paying special attention to the issues such as disclosure of sensitive information and power relations in an interview/survey context. WVB staff will be informed, guide and support in the in the study. Data collection processes will adhere to ethical standards, including informed consent, and with results anonymized prior to analysis. Ethical clearance of results is to be discussed further by relevant members of the advisory group.

#### The Impact Study will cover-

- 1. Prevalence of child marriage in the targeted village vs comparing village
- 2. Prevented Child marriage during the campaign
- 3. Magnitude of enrollment and dropout of adolescent girls in secondary education in the targeted village vs comparing village
- 4. Strengthen Child protection mechanism in the targeted village/union/thana vs comparing village/union/thana
- 5. Children enjoy positive, safe and peaceful relationship in their family and community

## **Proposed Data collection Area**

Qualitative data will be collected from through this study. Qualitative data will be collected from group and individual using FGD, KII, SWOT analysis and Impact Story collection. Consultant need to address and share the detail, analysis and reporting mechanism.

  - ♣ Sound knowledge and skill in determining appropriate methodology for conducting the short term, mid-term, baseline and end line research/ evaluation using qualitative methods.
  - **Experience** in developing Survey Tool both qualitative especially in child protection and advocacy area
  - ♣ Good facilitation skill to build capacity of enumerators and field staffs in the form of TOT
  - Excellent presentation skill to share findings to a national and international high-level audience
  - **★** Experience in writing research/evaluation reports using appropriate tables, charts & figures including test result
