1. BACKGROUND

Oxfam has been implementing "Resilience through Economic Empowerment, Climate Adaptation, Leadership and Learning (REECALL 2021)" project in the disaster-prone Char, Haor, and Coastal areas through 13 national partner NGO's in 13th districts. The project aim is "**By 2021 vulnerable women, men and institutions are more resilient to social, economic and climatic shock and stress**".
