#### **BASIS OF SELECTION**

Bidders should provide their lowest competitive quotes. All Bidders will be notified in writing should there be a significant change to the listed requirements. A Purchase Order will be issued to the responsible Bidder that is judged to be most advantageous to ACDI/VOCA in terms of delivery schedule and cost. ACDI/VOCA may accept any item or group of items of a bid. ACDI/VOCA reserves the right to make an award on any item for a quantity less than the quantity stated, at the unit prices quoted.

ACDI/VOCA may reject any quote that is determined to be nonresponsive. A responsive quote is one that complies with all terms and conditions of the RFQ. A quote must be complete, signed by an authorized signatory and delivered no later than the submission time and date indicated on the first page of this RFQ. ACDI/VOCA may reserve the right to waive any minor discrepancies in a quote.

This RFQ does not legally obligate ACDI/VOCA to award a contract. ACDI/VOCA reserves the right to fund/award any or none of the submitted quotes. No commitment is made, either expressed or implied, to compensate Bidders for costs incurred in the preparation and submission of their quotes.

#### ITEM DESCRIPTION

- Annual Medical Insurance Coverage includes both outpatient coverage and hospitalization coverage for 90 staffs and their dependents (with dental and optical benefits).
- Quotes should clearly spell out the premium rate per insured person per year (employee, spouse and child) and for different age ranges for both hospitalization coverage and

- outpatient coverage.
- Three plan options should have submitted for "Health Insurance on outpatient services":
  - 1<sup>st</sup> option benefit limit of 90,000 BDT per insured per year
  - 2<sup>nd</sup> option benefit limit of 100,000 BDT per insured per year and
  - 3<sup>rd</sup> option benefit limit of 120,000 BDT per insured per year
- Two plan options should have submitted for "Health Insurance on In-patient services":
  - 1st option benefit limit 350,000 BDT per insured per hospitalization and
  - **2<sup>nd</sup> option** benefit limit 400,000 BDT per insured per hospitalization.
- Quotes should also include life insurance (which includes death coverage and disability coverage –including short term/partial and long term/permanent).
- Two plan options should have submitted for "Life Insurance":
  - **1**<sup>st</sup> **option** benefit limit 18 times of gross salary for natural death and 36 times of gross salary for accidental death and
  - **2**<sup>nd</sup> **option** benefit limit 24 times of gross salary for natural death and 48 times of gross salary for accidental death.
- Quotes should include worker's compensation if available to include injury for employees in the workplace.
- Quotes should cover dental, optical, maternity & premium rate per insured per year.
- Quotes should cover Dengue, Monkey Pox and COVID-19 cases, Digital Claim Management System & More Convenient Cashless Treatment through Medical Card.
- Quotes should cover any other unforeseen (unrevealed yet) diseases/infections which may or may not be recognized as pandemic later on.
