Develop and Air Public Service Announcement (PSA) through multiple FM Radios to counter terrorism/extremism and violent extremism among mass people in Rajshahi, Sylhet and Chattogram.

Terms of Reference (ToR)

1. Project Background

The Asia Foundation (the Foundation) is implementing a 3-years project focusing on community policing to counter extremism. The goal of the project is to work collaboratively with law enforcement agencies to carry out Counter Terrorism (CT) efforts that effectively engage citizens in awareness raising, information sharing, and prevention initiatives through the community policing approach. The project is working in collaboration with local partners Songshoptaque, Manab Kallyan Parisad (MKP), and IDEA in three target divisions of Chittagong, Rajshahi, and Sylhet, respectively.

2. Program Context

The recent violence extremism (VE) in Bangladesh has its domestic origins in a series of unprecedented bomb blasts that took place during the Bengali New Year celebrations in 2001 and 2002, and a subsequent campaign rally in 2004. In 2005, nearly 500 explosions were set off in a half-hour timeframe by Jamaat-ul-Mujahideen (JMB)¹ in 64 districts across the country. Although GoB has since banned JMB, other terrorist groups and activities have sprung up. Some are linked to the now weakened JMB or neo-JMB activities. They include the gruesome murders of atheist, secular, and LGBTI (lesbian, gay, bisexual, transgender, and intersex) bloggers starting in 2014, and the July 2016 attack on the Holy Artisan Bakery in Dhaka's affluent diplomatic zone which resulted in 29 deaths including two police officers and all seven attackers who were well-educated youth from elite backgrounds. Although GoB lays blame on JMB, the Islamic State of Iraq and the Levant (ISIL) has claimed responsibility for the event. Many of the attacks on bloggers have been connected to a new extremist group – Ansarullah Bangla Team – which has developed mostly in urban settings through online media and which the Bangladesh Police (BP) states has roots in Al-Oaeda.²

These incidents have shocked Bangladesh and its people, and GoB has taken an outspoken stance on VE, including ongoing collaboration with the U.S. Government. This collaboration has included: the application of the 2009 Antiterrorism Act (amended in 2012 and 2013) to arrest foreign terrorist fighters; a serious commitment to international standards for controlling international money laundering that finances terrorism and increased compliance on aviation standards to strengthen border controls; and partnership on operations and capacity building to enhance CT operations, crisis response mechanisms, crime scene management, and community policing activities. GoB has also created the specialized Counterterrorism and Transnational Crime

Unit (CTTC) under the Dhaka Metropolitan Police (DMP) to track intelligence and follow up on terrorist activities.

Despite all these efforts, yet more needs to be done to systematically and effectively address VE. Within this context, law enforcement agencies as well as citizens can play a powerful role in CT through comprehensive strategies that combine intelligence gathering with community policing to improve coordination and information sharing across law enforcement agencies and with citizens. By partnering with the public, law enforcement can more effectively mobilize resources, gain access to quality data for analysis to inform action, and develop strategies that support a CT agenda.

3. About the Assignment

As part of the project, the Foundation is going to develop and air some Public Service Announcements (PSAs). The details are given below:

- Final report with views count.

Please note the final length of each of the PSAs will be finalized in consultation with the PEACE Team during the kick-off meeting and first draft of production.

The Foundation will provide the consultant with necessary support to undertake and implement the assignment and execute the objectives of this assignment. Such responsibilities include the following:
