TERMS OF REFERENCE FOR A CONSULTANT TO CONDUCT A LABOUR MARKET STUDY SURVEY

Title of the assignment	Labour Market Study to identify Market Potential of Occupational skills and training needs for the Adolescents/ youth programming
Purpose	To generate data for evidenced base data for Adolescent/ youth Programming
Location	Cox's Bazar District: Rohingya camps and host community locations
Estimated Duration	60 days

1. Background

Cox's Bazar District is currently hosting over 900,000 Rohingya refugees¹, including over 730,000 who arrived since August 2017. Over half (55 per cent) of the refugee population is estimated to be under the age of 18 while 31 per cent of refugee households are identified as extremely vulnerable, including childheaded households. Other estimates suggest that up to 20 per cent of the refugee population are youth between the ages of 15 to 24.

Meanwhile, over 80 per cent of adolescents and youth aged 15 to 24 are not in education or training. In 2019, UNICEF began to accelerate education and protection opportunities for adolescents aged 15 to 18 through an integrated adolescent programme targeting 40,000 adolescents (28,000 in camps and 12,000 in host communities). So far, there are 24 Multi-Purpose Child and Adolescent Centres (MPCs) in host communities with 5,860 adolescents attending and 34 MPCs in camps serving 6,454 adolescents. The programme covers life skills, psychosocial support, recreational facilities, case management & referral pathways services, vocational skills training and basic literacy and numeracy.

Occupational skills in the adolescent package refers to short practical course (Max.6 months) on specific trades/ occupations relevant to their context market needs. Where possible, courses will be selected based on location specific skills/ market analysis including demand and supply situation of skilled man power in camps. Additionally, upon completion of vocational skills training, adolescents will receive transferable skills which will help them setup enterprise of their own choice. Examples of such skills include; financial management skills, entrepreneurship and business communication skills.

Though substantial progress has been made through structures, Adolescents continue to express interest in taking on additional skills, such as Occupational Skills. In this context, UNICEF has identified a set of "key pillars" to Adolescents' girls and boys which it has planned to achieve to fulfill their rights, enhance their protection, safety and participation and to enhance more sharpened and strategic programming for most disadvantaged and marginalized adolescents' girls and boys. One of the four core commitments is; 4.3 Learning, Educate and provide formal and non-formal learning opportunity for adolescents' girls and boys

Strategic objective:

Adolescent boys and girls (10-18 years), especially the most disadvantaged and deprived in humanitarian/ recovery situation are engaged and have skills needed to actively participate in personal, social and economic development

Objective:

By 2020, Adolescent girls and boys in Bangladesh especially the most disadvantaged, access and utilize high quality basic social services in a safe and protected environment and are resilient and empowered as active agents of change

Description of Assignment

Under Output 3.4; BRAC with technical support from UNICEF intends to hire a consultant to conduct a Labour Market Study evidenced base Adolescent programming (Vocational Skills Training). The outcomes will include; identification of type of occupational skills/trades and identify potential jobs and employment opportunities for both Rohingya refugees in camps and host communities in Cox's Bazar, Bangladesh. The study will assess the potential training providers for internships; capacity, duration of training per trade, earnings per trade, marketability of products/ services, sustainability challenges, skills gaps based on sectors- sub-sectors, justification for trades in camps including accessibility, retention& completion, prevailing attitude and impact, safety(girls) and environmental impact. Design a 3-year projection per sectors/sub-sectors in both refugee camps and host communities.

The specific objectives of this assignment are summarised as follows:

- To come up with the most suitable trades for Adolescents and youths in Rohingya refugee camps and host communities in Cox's Bazar
- To identify opportunities and challenges faced by graduates in various trades/ courses and come
 up with key recommendations
- To provide an analysis of the most marketable occupations in view of access to employment, earnings for girls and comparisons based on non-traditional occupations
- Assess the priority skills gaps in the occupation categorized into skills type, levels, decent jobs and attitude of adolescents towards the skills/ trades
- Assess the capacity of private sector in the provision of identified market demanded courses and internship placement opportunities and Out-reach training support to Adolescents/ youths
- To assess the opportunities for self-employment, earnings and challenges Adolescents may face in initiating enterprises both in refugee camps and host community and come up with key recommendations
- Determine the relevance of courses/ trades currently being offered at the Multi-Purpose Child and Adolescent Centres.

Technical Guidance and Communication:

The consultant should maintain communication with BRAC to successfully conduct the assignment and will receive technical guidance from Education Manager and Child Protection Managers' of UNICEF. During the development of research tools, UNICEF and BRAC should be consulted to contextualize the tools.

Scope of Assignment:

The consultant is required to conduct a Labour Market study to analyze the skills gaps in both the camps and host community to identify relevant trades needed in the Labour market. The consultant is expected to perform the following key tasks:

- Develop a detailed work plan for execution of the assignment
- Come up with a list of sectors and sub-sectors with comparison to their earnings, training duration, challenges related to starting the business and make key recommendations based on the subsector
- Assess challenges faced by adolescents in getting employment with a focus on females and provide relevant recommendations

- Conduct and organize field visits to; interview and hold discussions with Adolescents (girls/ boys) both Rohingya refugees and host communities to assess their attitude towards Vocational Skills Training and views towards the services availed through the Multi-Purpose Child and Adolescent Centres.
- Analyze government policies that can promote or hinder skills development in Cox's Bazar
- Map out of existing skills and capacities for employment and gaps in relation to the job market, assessing profiles and preference of workers
- Conduct a field assessment based on the purpose and objectives of the consultancy
- Develop research/ study tools e.g. questionnaires, KII, IDI & FGD checklist for market assessment; graduate, employers, adolescents interested in vocational skills training, local government, trainers and partners implementing vocational skills
- Draw recommendations for drafting a realistic implementation and monitoring plan for training relevant marketable skills to adolescents in Rohingya camp, host community including sustainability strategy
- Inclusion of adolescents with disability in terms of training, participation, accessibility and identification potential training providers

The consultant or the incumbent company is expected to obtain and to adhere to BRAC and UNICEF ethical data collection protocols, including appropriate interaction with children under 18.

Methodology:

The study should follow both primary data collection and secondary data collection method.

Primary Data Collection Methods:

- Data collection, Primary data collection will include; interview with vocational graduates from Cox's Bazar to find out their experience and employability in the skills trained (Use of Key Informant Interviews, In-depth Interviews)
- Hold Focused Group Discussions with adolescents interested in vocational training disaggregated by gender and location (Refugee camp and host communities)
- Key Informant Interviews
 Obtain views of key stakeholders including; CSOs, NGOs, private sector, district officials, potential employers, training institutions where Snow ball technic of sampling may be applicable

Secondary Data Collection Methods:

Documentary survey
Review of secondary data, documents, assessment reports and market studies. The use a mix of
quantitative and qualitative methods to collect data, district officials, private sector employers,
vocational skills instructors and LMS reports conducted before in Cox's Bazar (Desk review)

Sampling and sample size:

• The consultant should take sample size using sampling technique. Primarily, the consultant is to target 1000 individual respondents; 650 from the refugee camps and 350 from the host communities segmented based on the following; gender, graduates from Vocational institutions, enterprises, adolescents, trainers, employers from these sectors and consumers of products and services. The assignment will cover both host community, three Upazilas and Rohingya community, six camps under Cox's Bazar district. It should be discussed and consulted with UNICEF and BRAC to determine the study area.

Data Analysis:

Gather data, collect, analyse and interpret it systematically using various methods and tools.
Quantitative data will be analysed using SPSS, both quantitative and qualitative data should be
used to find out employable sectors and assess the capacity of private sector and trainers who
offer such courses.

Deliverables:

An inception report not more than 5 pages;

- Detailing the methodology including research methods, sample framework, data collection procedures. Research tools will be approved by the Education and Child Protection team before data collection.
- Presentation of a draft report to the Education Team and Child Protection team for review and inputs before submission of the final report to in cooperate suggestions and recommendations.
- The report should cover core aspects of the set of outcome indicators with relevant annexes and data disaggregated to aid programming and inform future evaluation of impact
- Disseminate Labour Market findings to key stakeholders in Cox's Bazar, Bangladesh through a one day's dissemination validation workshop organized for key stakeholders
- Soft copy of all data collection tools and Labour Market Study data set
- Conduct stakeholder consultations with key staff members in the adolescent programming, policy makers, employers, job seekers and literature review to support appropriate recommendations together with a report
