#### 1. Introduction

The Centre for Entrepreneurship Development (CED) at BRAC University, established in 2011 under the visionary leadership of Sir Fazle Hasan Abed (KCMG), stands as a driving force in building an inclusive entrepreneurial ecosystem and sustainable innovation in Bangladesh. CED nurtures and empowers aspiring and established entrepreneurs, promotes social innovation, scales knowledge and skills, supports community development, conducts interdisciplinary research, advances welfare initiatives, and forges development opportunities through strategic networking.

As an implementing partner of the EmPower Phase II project funded by UN Women and UNEP, CED is inviting applications from qualified individual consultants/consulting firms to identify the barriers and challenges faced by women, particularly from marginal and climate-vulnerable communities, in accessing finance for renewable energy-based, climate-resilient livelihoods across five targeted districts. This initiative contributes to the project's broader goal of strengthening gender-responsive, climate-resilient livelihoods and financial inclusion for women and marginalized groups in Bangladesh.

#### 2. Project Description

Bangladesh, one of the most climate-vulnerable countries globally, faces significant challenges from rising sea levels, extreme weather events, and environmental degradation. Women and marginalized groups are disproportionately impacted due to socio-economic, financial, and structural barriers. In response, this project: Strengthening and scaling up climate-resilient livelihoods for women and other marginalized groups in the climate hotspots of Bangladesh under the EmPower II initiative seeks to promote inclusive, renewable energy-based, climate-resilient livelihoods by strengthening partnerships, building capacities, and facilitating access to finance and resources.

### 3. Objectives of Assignment

The main objectives of this consultancy are to identify the barriers and challenges faced by women, particularly from marginal and climate-vulnerable communities in accessing finance for renewable energy-based, climate-resilient livelihoods in the mentioned geographic location, which has been divided into clusters.

#### 4. Geographic Location

- Cluster 1: Khulna & Satkhira (Upazilas: Koyra, Dacope, Shyamnagar, Kaliganj)
- Cluster 2: Jamalpur & Kurigram (Upazilas: Islampur, Dewanganj, Kurigram Sadar, Chilmari)
- Cluster 3: Cox's Bazar (Upazilas: Chakaria, Teknaf)

# 5. Scope of Work

The individual consultant/consulting firm will be responsible for delivering the following:

- Review of existing literature, government policies, and data to understand barriers faced by women from marginal communities in accessing financial resources for renewable energy businesses in the five-target climate-vulnerable districts.
- Engage with key stakeholders including policymakers, local NGOs, financial institutions, civil society organizations, and renewable energy sector experts through qualitative methods (e.g., Key Informant Interviews and Focus Group Discussions) to gather insights on the financial inclusion challenges of women in the targeted areas at mentioned districts.
- Facilitate consultations with marginalized women in the climate-vulnerable districts to document lived experiences and challenges related to access to finance.
- Analyze the collected data to identify socio-economic, institutional, and cultural barriers that limit women's access to credit and financial services.
- Prepare a report documenting the barriers and challenges identified, ensuring the findings are grounded in the context of marginal women's access to finance in the mentioned climate vulnerable districts.

#### 6. Deliverables

- An inception report outlining the methodology, stakeholder engagement plan, sample selection criteria, and proposed structure of the final deliverable. This will serve as the guiding framework for the assignment and be submitted within the first week of contract signing.
- A draft report (maximum 10 pages) presenting preliminary findings on barriers and challenges faced by women in accessing finance for renewable energy-based livelihoods in the five targeted districts. The draft will include an overview of existing initiatives, financial access gaps, and emerging opportunities.
- A final report incorporating feedback provided by CED on the draft, with detailed analysis of the findings and practical recommendations on how these can inform and strengthen EmPower II interventions for improving women's access to finance in climate-vulnerable communities.

### 7. Duration of Assignment

The duration of the Assignment is 2 months, possibly starting from 01 October 2025.

#### 8. Selection Criteria

# A. Eligible Applicants:

This assignment is open to individual consultants or consulting firms with proven expertise in gender-responsive livelihood assessments, renewable energy entrepreneurship, and socio-economic research. Eligible applicants must:

• Lead consultant (in case of a firm) or individual applicant must hold at least a Master's degree in a relevant discipline such as economics, gender studies, development studies, environmental science, or other related social sciences.

- Independent consultants/consultancy firms/research institutions/NGOs with at least 10 years' experience in gender analysis, access-to-finance studies, and/or renewable energy-related livelihood assessments.
- Have a proven track record in conducting field-based research with marginalized and climate-vulnerable communities, including the use of qualitative methods (e.g., KIIs, FGDs).
- Be legally eligible to operate in Bangladesh, with valid documentation (e.g., TIN, trade license, or institutional registration, if applicable).
- Be proficient in preparing analytical reports in English, with the ability to engage local communities in Bangla where required.
- Relevant prior experience in identifying barriers to women's access to finance, particularly for renewable energy-based livelihoods, will be given preference.

# **B.** Eligible Proposals Must:

- Clearly align with the objective of identifying barriers and challenges faced by women from marginal communities in accessing finance for renewable energy-based livelihoods in the five targeted climate-vulnerable districts.
- Include a practical and inclusive methodology for data collection, analysis, and validation (e.g., KIIs, FGDs).
- Address financial, cultural, and institutional challenges that limit women's participation in renewable energy-based livelihoods.
- Outline a realistic work plan and timeline, including the delivery of an inception report, draft report, and final report (maximum 10 pages).
- Submit a cover letter clearly demonstrating relevant previous experience and outlining the applicant's capacity to deliver the assignment within the agreed timeline.
- Demonstrate a strong commitment to gender equality, inclusion, and the socio-economic empowerment of marginalized women.
- Address intersectional issues of gender, climate vulnerability, and financial inclusion.
- Commit to timely submission of high-quality deliverables.
