Role definition

Role purpose

The role holder will be responsible for managing the *Expanding Civic Space and active CSO participation and strengthened governance system in Bangladesh* project, on behalf of Christian Aid, a project supported by European Union in Bangladesh. There are two implementing partners and a number of CSOs working on the ground. The **Project Manager** will ensure quality program implementation, including providing strategic guidance to the partners and overseeing budget and programme performance management, M&E and relationships with external actors including government authorities and donors. The role will also represent Christian Aid in meetings and networks and will increase the profile and visibility of Christian Aid's work. The role holder will manage the project and support the wider programme team ensuring the integration of the project within the programme.

- Take the lead in project planning and coordination to ensure timely and quality implementation of all activities
- Provide strategic guidance in unifying approaches between the project partners with different set of expertise and maintain open and effective communication amongst the project partner and team members

- Undertake regular field visits to monitor the programme progress and ensure the quality of programmes.

Christian Aid has been working in Bangladesh since 1972. We are recognized for our work on emergency response programme, climate change, disaster risk management, gender equality and human rights issues. The Project Manager will be responsible for project and partnership management with quality and standard. The PM will manage the ECSAP project and its partners in line with the agreed log frame and plan. He/she will network and build relationships to enhance Christian Aid's economic justice programming and contribute to Christian Aid's overall strategy. The post holder will report to Programme Manager- Economic Justice.

Role requirements

Relationships

External He/she will work closely with project partners and lead the implementation. He/she will establish and maintain a wide network of contacts with partners, networks, stakeholders and different coalitions/sectors/clusters. Represent Christian aid externally when required.

Internal Build strong relationship with the Bangladesh country team. The position will work closely with Christian Aid's managers, Accountability, Programme Funding, MEAL, safeguarding and other thematic leads and the communications team. He/she will work closely with staff working on economic justice, gender, inclusion and protection. The role will be supported and mentored by Programme Manager – Economic Justice.

Decision making: Required to take lead in providing decisions in relation to the project, "Promoting gender justice for women workers in the Readymade Garment sector and advocating women's safety during local commute and public spaces in Bangladesh" MEAL related work. He/she is



required to establish and strengthen contacts with the existing partners and required to make decisions to ensure partner portfolios are running effectively.
