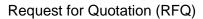

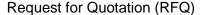

Duration of Quote:	All quotes submitted must be valid for 90 days from the Submission Deadline specified below. - 6. <u>Right to Select/Reject</u>: HKI reserves the right to select and negotiate with those firms it determines, in its sole discretion, to be qualified for competitive quotes and to terminate negotiations without incurring any liability. HKI also reserves the right to reject any or all quotes received without explanation.
- 7. Reserved Rights: RFQ responses become the property of HKI. HKI reserves the right in its sole discretion:
 - To disqualify any offer based on Bidder's failure to follow solicitation instructions;
