MJF is planning to develop a comprehensive management plan for each VCFs and its adjacent streams for enriching biodiversity, uplifting livelihood and enhancing availability of water through better management of natural resources. Introduction

Manusher Jonno Foundation (MJF) a non-government and non-profit organization works with local organizations to improve the well-being of poor and marginalized communities, through increasing their voices, capacities, realization of their fundamental rights and demand-driven institutional responsiveness. MJF believes in equal rights of all human beings and therefore, is working for upholding the dignity of socially excluded and marginalized people. MJF is dedicated to mainstreaming gender in its operation in terms of participation, capacity, and programmatic focus. It is one of the largest national non-governmental organization in Bangladesh providing grants and capacity building support for human rights and good governance.

MJF is implementing a four-year project titled "Community based Resilience, Women's Empowerment & Action (CREA)" funded by the Embassy of Sweden with the goal to build women's leadership capacity and increase resilience of the most vulnerable communities to address climate change impacts. Under this project, MJF has already established partnerships with 13 organizations to work directly for addressing impacts of climate change, GVB, and child marriage. A total of 22680 HHs from climate vulnerable coast, floodplain, haor and hill areas are engaged with the project. The project is working to achieve 5 outcomes and those are a) Service providers both public and local government institutions are responsive, and increased access to the quality services of the community especially women and girls b) Improved resilience of most vulnerable coastal, char, hill and haor communities to climate change impacts c) Empowered women and girls are dealing with inequality, social injustice, violence incidences and participated in voice raising and protests d) Strong voices and decisions are in place against DVAW and child marriage and reduced the rate of child marriage, SRHR and DVAW in the selected climate vulnerable areas e) Risks related to poverty will be decreased with increased family income and alternative livelihoods options.

Conservation of Village Common Forests (VCFs) and adjacent streams with an aim to improve biodiversity and availability of water in the streams is one of the key activities of the project. VCF fulfills the needs of many indigenous people by providing bamboo, timber, medicinal plants, fuel wood, and other minor forest products. Furthermore, VCF safeguards village water sources such as springs and irrigation canals. Therefore, the protection and preservation of VCF become crucial for livelihood, environmental, medicinal, cultural and religious needs of indigenous communities¹. Besides, conservation of VCFs will contribute in carbon sequestration and ultimately support in reducing negative impacts of climate change as well as global warming.

In this context, a total of four VCFs (2 at Rangamati and 2 at Bandarban) were taken under the project to improve their management by engaging communities living around the VCF. MJF has planned to identify the status of VCFs and adjacent streams, capture traditional practice of VCF management, and finally come up with a management plan for each VCFs so that communities can manage those properly.

Objective: Develop a comprehensive management plan for each VCFs and its adjacent streams for enriching biodiversity, uplifting livelihood and enhancing availability of water through better management of natural resources

Scope of the assignment:

- 1. Develop GIS map of each VCF and adjacent stream
- 2. Identify floral biodiversity of each VCF and adjacent streams
- 3. Identify and suggest suitable native species for long, medium and short rotation plantation for VCF to support biodiversity and livelihood
- 4. Explore & suggest suitable alternative climate-smart & environment friendly livelihoods
- 5. Identify and suggest suitable native species to plant around the streams to enhance water availability
- 6. Explore traditional practice of VCF management by the communities
