1. Background

Youth and Social Cohesion is one of MJF's five program areas under Excluded People's Rights in Bangladesh program. The goal of the Youth and Social Cohesion is: Young people have opportunities to become active citizens and agents of progressive change. Currently Bangladesh is passing through a phase called 'Demographic Dividend' where 60% of the total population is between the age of 16 to 35 years. In this context, the need of Life skills is enormous for every individual to deal effectively with the demands and challenges of everyday life. This is more applicable for the youth who are the potential contributors to the development of a country. In Bangladesh they are loosely grouped into three broad categories of skills: cognitive skills for analyzing and using information, personal skills for developing personal agency and managing oneself, and inter-personal skills for communicating and interacting effectively with others. However, Youth and Social Cohesion program has special attention on life skill issue so that the youth can contribute positively in society.

Objective:

The overall objective of developing the manual is:

- 1. To use the manual as a facilitation tool for conducting life skill session
- 2. To have a document that correspond with the practical needs of the youth
- 3. To build the capacity of the potential youth to be active citizens

2. Scope of Work:

- Reviewing the existing documents
- Exploring the need of the project beneficiaries though partner organizations
- Drafting the manual
- Validating at field (project locations)
- Peer de briefing with experts with the first draft

3. Possible Issues Covered in the Module Content:

Potential Session content

1. Active citizenship

- a. Basic human rights including youth rights and community rights
- b. Roles and responsibilities of citizen
- c. Women rights and gender-based violence (dowry, child marriage, reproductive health, sexual harassments)
- d. Involvement in socio-cultural activities
- e. Democracy and local governance (identifying legal support point, GD, FIR)

2. Leadership skill development

- a. Networking and persuasion (grassroots advocacy, lobbying) skill
- b. Self-awareness, self-confidence building
- c. Creative thinking and problem solving capability
- d. Interpersonal communication and effective body language
- e. Public speaking skill

3. Volunteerism in positive social action

- a. Group mobilization for addressing social issues
- b. Design community development intervention
- c. Protest, movement, and prevention (drug abuse and gender violence, day observance)
- d. Environmental safeguard (cleanliness, drainage system, primary healthcare, water, sanitation, nutrition)

4. Employment opportunity

- a. Carrier planning and preparing CV
- b. Vocation training for job market (ICT, electrician, RMG, etc.)
- c. Online training
- d. Entrepreneurship & Financial Management

5. Preventing violent extremism

- a. Safe use of social media and gadgets
- b. Stress management, Mental Wellbeing-Psychosocial & Psychosexual counseling/support
- c. Peace, tolerance, and social cohesion

6. Representation in the national forum

a. Participation in decision making process

4. Methodology:

This will be practical needs based life skill manual that incorporates the demand of the youth belong to both rural and urban settings. The consultant will use the data derived from the field. The content has to be easy to conceptualize and use in the sessions in a certain time limit. Session length will be 1.5- 2 hours.
