

Terms of Reference (ToR) Baseline Survey on Knowledge, Attitude, Behavior and Practices on Ending Child Marriage and Violence Against Children

Date: February 12, 2023

#### Background

Shushilan is a national Non-Governmental Organization (NGO), established in 1991. Its five programs are Socio Economic Development Program; Education & ICT and Health & Nutrition Program; Disaster, Climate Change and Environmental Resource Management Program; Human Rights and Good Governance Program and Sustainable People's Organization Program. Shushilan has emerged as a leading national organization with presence across almost all of Bangladesh over 31 years' experience of health and nutrition, mother and childcare, adolescent health, promotion of health & hygiene, livelihood, disaster response, human rights, environmental resource management etc.

Shushilan & UNICEF has long standing partnership & recently an agreement has been signed between Shushilan & UNICEF for implementing a project "Social and Behavior Change Programme for prevention of Violence Against Children (including child marriage) and promotion of children and adolescent well-being" at 8 Upazila's under 3 districts. As part of initial starting of the project, we are planning to collect baseline information & this TOR is reflecting outline for hiring a consultant/ consultant farm for conducting the baseline survey.

#### **Project brief**

The project will be implemented from the period of 2 years (12 Dec'22 to11 Dec'2024) to address the multiple vulnerabilities of children and adolescents in Bhola, Patuakhali and Barguna district, Shushilan in consultation with UNICEF are implementing the project to facilitate empowerment of adolescents and their parents/caregivers through creating positive norms of familial encouragement, community approval, civic engagement and increased awareness about issues and challenges around children, adolescents and to enable them to realize their rights and raise their voices. The initiatives will strengthen the capacity of the partners/stakeholders on Social and Behaviour Change, generate local evidence, foster community engagement, gender transformative approach & interventions at the individual, community and institutional level and empower communities to take greater responsibility and create an enabling environment to foster awareness e.g., child rights, gender-based violence, disability issues and basic rights.

The main aim of this project is to protect children & adolescent from any form of harm & make them empowered so that they can raise their voice on their issues.

The project includes the set of specific interventions that focus on strengthening various elements of the child protection (both formal and informal elements) at the community level, thus empowering local communities to strengthen the protection of children from abuse, neglect, exploitation and other forms of violence. The project will strengthen both the protective environment for children, as well as children themselves, in order to improve their well-being and fulfill their rights to protection. The project provides comprehensive framework for child protection work at the community level and will help to establish an evidence base for advocacy efforts at various levels. It uses a systems strengthening approach which emphasizes prevention, protection and response, coordination between sectors and integrated responses that can benefit all children.

#### **Purpose of the survey**

The purpose of the baseline survey is to understand current Knowledge, Attitude, Behaviour & Practice (KABP) of parents (father & mother), children, adolescents, and community influential & religious leaders on Early Child Marriage (ECM) and Violence Against Children (VAC) including community engagement & feedback mechanism of the targeted areas. The information will enable project indicators at output level to be measured and tracked.

#### The Output of the project and expected results

The project outputs have been stated here and based on output measure expected results have been prepared. These are:

### Output 1- Study to establish local level baseline on KABP on ECM and VAC is conducted

- Current Early marriage rate/ status of targeted areas
- Knowledge, attitudes & practice on child rights
- Violence against children & adolescents (including children and adolescents with disabilities)
- Vulnerable children and their families' opportunities to participate in decision making processes;
- School dropout status (primary & secondary)

# Output 2- By 30 November 2024, SBC capacity of implementing partners and influential leaders increased to effectively implement community engagement activities to promote desired behaviors in targeted Upazilas

- Social harmful norms on child marriage, gender, child labor, child protection
- Parent's perception regarding child marriage

#### Methodology

A mixed methods approach will be employed for this study including qualitative and quantitative methods. Data should be collected using the standard tools (questionnaire, guideline, pre-testing). For qualitative method-FGD, KII, please identify the key person/ stakeholder who can give info and for FGD different groups like adolescents, caregivers, community /influential leaders etc.

First, would be the literature review and secondary data analysis and synthesis of quantitative and quantitative evidence on knowledge, attitude, and practices of study population on the project study focus, and second phase will focus on a field study to collect data to fill the identified evidence gaps. The agency needs to come up with a proposed mixed methods approach that considers a strong balance between "the numbers and explanations" for answering the study's purpose and objectives. The agency should also identify expected limitations, risks, and ethical considerations for the assessment.

#### **Geographical Location**

The sampling should consider the geographical of Shushilan SBC project areas UNICEF (The sampling size should be representative for generalization of the study findings and should consider every district of Barishal division of Bangladesh, and rural as well as urban, and in hard to reach/media dark locations.

#### **Study Protocol**

The agency will be responsible for generating KABP survey protocols. The protocol will include:

<u>Study design</u>: The agency will propose the most appropriate design in line with UNICEF's result framework/theory of change for SBC, which will be subject to review by UNICEF.

<u>Sampling</u>: The agency will propose the most appropriate sampling. The sample should be representative of the different segments of population and of the respondent types described above. It should consider gender, geographic locations, social exclusion etc.

<u>Methods of data collection</u>: To include quantitative and qualitative methods demonstrating inclusion of key stakeholders at various levels; including the data collection tools and appropriate qualitative and quantitative methods to be used. It is highly encouraged to adapt innovative approaches using the digital platform for data collection.

<u>Plan for data analysis:</u> The agency will propose a detailed Data Analysis Plan including software to be used. The proposal should include insights into how the quantitative and qualitative data will be analyzed and triangulated, how the different sub-groups will be treated in the analysis.

<u>Budget and study schedule:</u> The agency will be required to provide a detailed budget and timeframe with the submission. A detailed and realistic study schedule/ work plan should be included, indicating timing of activities, results and regular reporting, as required.

<u>Ethical considerations</u>: The institution/consultant is required to take time to get familiar with UNICEF's Procedure for ethical standards in Research, Evaluation, Data collection and Analysis.

#### **Profiles of the Lead Consultant**

The consultant should have -

- A higher degree in Statistics/Social Science/Anthropology/Development Studies/Mass Communication or any other relevant research-based study.
- Proven Experience on the development context of Bangladesh and experience on working with mixed culture i.e. coastal community.
- Proven experience in conducting baseline/midline/end line study and participatory approaches.
- Proven experiences study on Social and Behaviour Change Programme (SBC) for prevention of Violence Against Children (including child marriage) and promotion of children and adolescent well-being will added extra value.
- Experience in combining qualitative and quantitative survey methods using standards prescribed tools and develop by consultants.
- Experience in statistical analysis and triangulate the quantitative and qualitative data appropriately.
- Excellent report writing skill in English and presentation skill.

#### Code of conduct

#### **Application Submission Information:**

•Interested applicant(s) should email a cover letter and CV (maximum 4 pages; with references), VAT & TIN registration copy, and NID copy.

•If it is a company then it needs to share the profile(s) and documentation of legal status, and registration as a company (Trade License).

•Bank Solvency Certificate (for both company and individual) –optional.

•Applicants must share technical & financial offers and technical proposals (maximum 15 pages) including the proposed methodologies and proposed schedule.

•The financial proposal should cover all the costs of the evaluation from the consultant's end (consultant's fee, field operations cost, accommodation, per diem, air tickets, and transportation to the field to collect data, food and other related costs).
