2.INTRODUCTION

This document provides Terms of Reference for the Baseline Study of Save the Children's Sponsorship program in Gaibandha (Rural), Bangladesh.

'Shishuder Jonno' Program is a sponsorship initiative of Save the Children in Bangladesh (SCiBD) to support development of children particularly who are deprived from basic needs and services like health, education and living opportunities. The program is about to extend its implementation area to Saghata upazila of Gaibandha district under joint funding of SC-US and SC-Korea. Project implementation in the area will start from 2021 and continue till 2034. The objective of the project is to support development of children particularly who are deprived from basic needs and services like early years of development, education, and child rights. Target group of the program includes children from birth to nineteen years following a 'life cycle approach'. Corresponding community, household, families, parents of program beneficiary children, teachers and local duty bearers are also in focus for the program intervention.

The Baseline study will be conducted to collect the data before initiation of program implementation to answer the baseline questions. In addition, the baseline will also investigate additional thematic issues including- equity of outcomes, including gender dynamics, disability, coverage of the intervention, integration of programming and child participation. It will adopt both quantitative and qualitative approaches to provide a comprehensive understanding of the beneficiary population and local context in relation to the program objectives and expected outcomes.

The project background, scope of the baseline, key questions, intended methodology, reporting and governance, key deliverables and timeframes for its implementation are provided in the sections that follow.

3. PROJECT BACKGROUND

Save the Children International in Bangladesh (SCiBD) is a leading child right based organization, currently covering a wide range of geographical areas in the Dhaka, Khulna, Barishal, Chattogram, Rajshahi, Sylhet and Rangpur Divisions. SCiBD works in number of thematic areas, including education, child protection, policy rights and governance, health and nutrition and HIV/AIDS, child poverty and emergency.

'Shishuder Jonno' (translated 'For the children') Program is a sponsorship initiative of Save the Children in Bangladesh (SCiBD) to support development of children particularly who are deprived from basic needs and services like health, education and living opportunities. Target group of the program includes children from birth to nineteen years following a 'life cycle approach'. Corresponding community, household, families, and parents of program beneficiary children are also in focus for the program intervention. Under the program there are five core components namely: (a) Early Childhood Care & Development (ECCD) (b) Basic Education (BE) along with ICT in education (c) School Health & Nutrition (SHN) (d) Maternal, Newborn, and Child Health and Nutrition (MNCHN) & (e) Adolescent Development (AD) which include both ASRH and ASST component. There are two other non-core program components namely- (a) Child Protection (CP) and (b) Child Rights and Governance (CRG) as well as a cross-cutting component namely- Gender Equality and Community Mobilization, which is an implementation principle for all program components.



But, for Gaibandha Impact Area, program management has consciously decided to limit to three core components- (a) Early Childhood Care & Development (ECCD), (b) Basic Education (BE), c) Adolescent Development (AD) which will focus mainly Child Marriage prevention with the support of one non-core program component, and (d) Child Protection (CP). Additionally, Community Mobilization will be integrated as part of program implementation. This decision came from the program management in consultation with the donor and country management to fit with overall strategic needs and scope of Sponsorship program as a whole.

'Shishuder Jonno' program currently has two Impact Areas (IAs)- Barishal (rural) and Dhaka City (urban). Phase-out Sponsor transfer process completed from old IA Meherpur to the existing IA (Barishal) in 2019. The program had already started process of selecting the new impact area/s and assessed all 64 districts of the country based on a variety of factors such as- poverty, education, health, climate change, existence of SCI other programs, non-existence of sponsorship programs of other organizations, child protection and safety security etc. Initially the Program shortlisted 19 districts, then 6 districts and finally shortlisted 3 districts (Gaibandha, Jhalokathi and Barishal). Through a series of activities, such as a reconnaissance survey and Phase-II committee planning meeting, Saghata upazila of Gaibandha district was finally selected as the new impact area of the SI program.

Gaibandha district is geographically different from the other districts of Bangladesh because of its vulnerability to disasters. Flood and river erosion are the major events which mostly affect the lives of char land people especially in 4 upazillas- namely Saghata, Fulchari, Gaibandha Sadar and Sundarganj. The situation is especially worse in Saghata upazila due to frequent disaster, poor livelihood opportunities, and lack of awareness of disadvantaged communities and remoteness. The aggregated population of Gaibandha district is 23,79,255 of which 11,69,127 are male and 12,10,128 are female. Indigenous community such as santal belong to this district. Child marriage is high in these areas due to lack of awareness on its consequential affects and social beliefs, taboos and attitudes (nationally highest in Rangpur & Rajshahi divisions). Dowry, violence against women and child labour are still very high in this district. Physical and humiliating punishment (PHP) is also prevalent. Though Government has passed law for banning of corporal punishment in school, in reality, there is lack of enforcement of it due to cultural practices.

Based on population, the total reach projection in the next 12 years is as follows.

This program will be implemented directly by SKS Foundation with the technical guidance from Save the Children Bangladesh Country Office and strategic direction of SCUS.

In 2020, a situation analysis was conducted to learn more about the context and explore program opportunities in Saghata Upazila. Based on the findings of the situation analysis, program was designed for Gaibandha impact area.

4. SCOPE OF BASELINE

4.1 Purpose and key questions

The sponsorship program will conduct a Baseline study before its program implementation within the geographic jurisdiction through a neutral and external consulting firm maintaining SC's Evaluation Policy. Based on that, the overall objectives of Gaibandha Baseline Survey are-

The main purpose of the baseline study is to prepare a pre-project/baseline information base of the target beneficiaries as per the indicators of project objectives, specific objectives and expected results specified in the project document and the project log-frame. This baseline study will document the situation regarding a) access to services, b) gaps of existing GoB and NGO services, c) challenges and prospects and d) priority needs related to Early Years Pre-Primary, Primary, Basic Education, Child Marriage and Child Protection issues within the Gaibandha Impact Area.

The specific objectives of the baseline study are the following:

- a) To collect the baseline benchmark figures of the Logical framework indicators
- b) To analyze the verifiable indicators from the project log frame to assess the relevant information of existing situation of project's targeted beneficiaries (focusing on gender, diversity and marginality), service providers, and/or related stakeholders
- c) To use those pre-project information as a reference point and set monitoring targets and evaluation (midterm and endline) targets of all performance indicators for the IPTT
- d) To gain actionable insights and recommendation for program for further refinement of the design of interventions with a view to achieve program goal and objectives at the end of the program

Key questions that the Baseline study will answer are-



- What are the baseline values of the logical framework indicators?
- What are the potential influencing factors in achieving intended outcomes of the project?
- What is the feasibility, appropriateness, and acceptability of programme?
- What would be priority for the beneficiaries and how they could be benefited from the program design?

Overall, the program intends to acquire information on the following areas from the Evaluation (baseline, midline, endline) of the SJ program in Gaibandha district-

- Assess the intended and unintended, both positive and negative, outcomes and impacts of child sponsorship programming in Impact Area.
- Learn if core programming interventions has improved the lives of children living in the impact area and beyond
- Gain actionable insights and recommendations for future child sponsorship programming to improve immediate and sustainable outcomes and impacts for children, families, and communities in current and future impact areas.

In addition to the core programming outcomes mentioned above, the complete evaluation will also investigate additional thematic issues including: equity of outcomes, including gender dynamics, coverage of the intervention, integration of programming and child protection. Therefore, during development of methodology, the Baseline Team must consider the overall purpose of the Evaluation of the program in Gaibandha impact area, along with the purpose of the baseline study, so that in time the baseline study can contribute effectively to the overall evaluation.

4.2 Scope

Baseline evaluation

The overall evaluation will specifically focus on four key areas of the program- Early Childhood Care and Development, Basic Education, Adolescent Development (Child Marriage) and Child Protection As this baseline study is part of the Evaluation of SJ program in Gaibandha IA, all four components will be included in the baseline study as well, in addition to some cross-cutting areas, including gender dynamics, disability, integration of programming and child participation. Evaluation will be conducted only in the ten selected unions of Saghata Upazila of Gaibandha District. Many of these areas are remote and hard to reach 'Char' areas. Therefore, appropriate resource allocation and time allocation should be considered accordingly.

Country level indicator wise data collection

In addition to the baseline data collection, data against some indicators related with Country Strategy Plan (CSP) would be collected from same sample group while collecting Baseline data. However, there is no requirement for separate methodology for this part. Also, this data need not any analysis to be done. Only the clean raw data would be considered as deliverable for this country level indicator part. List of the indicators are given in the Annex-2.

4.4 Secondary Questions

In addition, the following specific questions should also be considered for the baselines-

5. EVALUATION METHODOLOGY

5.1 Research design and sampling

It is expected that this evaluation will involve both quantitative and qualitative approaches, using quasiexperimental design (covering both program participant and non-participant/comparison group), including appropriate sample size based on population. Detailed design of the complete evaluation of Gaibandha is expected from the Baseline team. As this is the baseline study, both methodology of the complete evaluation (Baseline, Midline, Endline) of Gaibandha IA, and detailed methodology of the baseline study in particular is expected from the Baseline Team.

5.2 Data

All primary data collected during the evaluation must facilitate disaggregation by gender, age, disability, location or remoteness, vulnerability status (natural disaster, migration status, etc.) (as necessary by the program). Save the Children will provide guidance on tools and classification schemes.



Existing Save the Children data sources that can be drawn on in the evaluation include:

- Gaibandha Situation Analysis
- Urban Baseline Study
- Barishal Baseline Study

Save the Children will not provide enumerators to assist with primary data collection. Data triangulation is expected for this evaluation. It will be a requirement of the Baseline team to source additional external data sources to add value to the evaluation, such as national/government administrative data.

A range of project documentation will be made available to the Baseline team that provides information about the design, implementation, and operation of the Program. Documents include:

- Vision for Impact Area Presence (VIAP)
- Situation Analysis report
- Indicators of Gaibandha IA
- Program cycle of SJ

The Baseline team is required to adhere to the Save the Children Child Safeguarding, Data protection and Privacy policies throughout all project activities. All the data, reports and other deliverables produced in this study will be treated as the property of Save the Children and information, data or deliverables related to this assignment cannot be sold, used or reproduced in any manner by the Baseline Team without prior permission from the Save the Children.

5.3 Ethical considerations

It is expected that this baseline will be:

- Child participatory. Children should be meaningfully involved in the evaluation as a holistic process and not only as informants. Refer to the Practice Standards in Children's Participation (International Save the Children Alliance 2005); and Global Indicator technical guidance (SCI M&E handouts Package, Volume 2).
- **Inclusive**. Ensure that children from different ethnic, social and religious backgrounds have the chance to participate, as well as children with disabilities and children who may be excluded or discriminated against in their community.
- **Ethical**: The baseline must be guided by the following ethical considerations:
 - o Child safeguarding demonstrating the highest standards of behavior towards children
 - Sensitive to child rights, gender, inclusion and cultural contexts
 - Openness of information given, to the highest possible degree to all involved parties
 - Confidentiality and data protection measures will be put in place to protect the identity
 of all participants and any other information that may put them or others at risk.
 - O Public access to the results when there are not special considerations against this
 - o Broad participation the relevant parties should be involved where possible
 - Reliability and independence the evaluation should be conducted so that findings and conclusions are correct and trustworthy

It is expected that:

- Data collection methods will be age and gender appropriate.
- Baseline activities will provide a safe, creative space where children feel that their thoughts and ideas are important.



- A risk assessment will be conducted that includes any risks related to children or young people's participation.
- Informed consent will be used where possible.
- The baseline will explore any personal and professional influence or potential bias among those who are collecting or analysing data and addressed or mitigated ethically.

The Baseline team will be required to obtain approval from a Human Research Ethics Committee. Save the Children will provide assistance with this process.

- A team leader will be appointed who has the seniority and experience in leading complex evaluation projects, and who has the ability and standing to lead a team toward a common goal.
- The team has the ability to commit to the terms of the project, and have adequate and available skilled resources to dedicate to this evaluation over the period.
- The team has a strong track record of working flexibly to accommodate changes as the project is implemented.

9. TECHNICAL EVALUATION CRITERIA

The organization will assign a committee composed of management and technical team to evaluate the proposals submitted by consulting firms/firms. One representative must be from the Central PDQ MEAL team. The selection committee will evaluate the bidders based on the criteria set below. The consulting firm/firm is expected to provide detailed information based on the given framework to ensure fair and effective comparison. The committee reserves the right to drop a competitor that scores the least. The proposals submitted will be reviewed based on the set criteria.

The exact technical evaluation criteria can vary but the standard practice is:

Benchmark scoring point:

Step I: To be potential candidate to conduct the assessment, the bidder must score at least 50% in technical proposal (out of 50).

Step 2: During the evaluation technical proposal of 50% of technical score, Top Three scored will be selected for further screening through oral presentation. The overall scoring should consider the technical proposal, the financial proposal, and oral presentation.

Step 3: Financial proposal will be reviewed and scored out of 40 of Top three scored at least 50% in technical proposal and the combine comparative statement will be conducted for only top three scorer. Finally, Save the Children will award the baseline with highest scorer consulting firm.
