VSO Bangladesh seeks Bid Development Consultants (Technical Proposal Writer) for upcoming UNFPA restricted funding opportunities in the areas of life skills training related to Health and Livelihoods. Once deployed the consultant will be working with the bid team and lead on the drafting of high-quality bid documents in line with donor guidelines.

**Scope of Work:** The scope of work below outlines the general parameters for services VSO expects the consultant to complete as part of a consultancy. VSO will provide the consultant with a written work order prior to any engagement describing a specific scope of work and timeline for the delivery of any final work products. To the extent practicable, the work order will also outline any logistical details including expected travel and related expenses in the work order.



# Skills, Qualifications, and Experience

#### Responsibilities

- Conduct background research on relevant topics expected to be included in the relevant upcoming opportunity.
- Prepare a written summary of the key findings from background research, including source documents and resources;
- Support proposal design in coordination with partners and VSO staff;
- Coordinate the bid timeline and ensure relevant stakeholders can contribute effectively to the bid;
- Draft high-quality bid materials in correspondence with donor criteria and guidelines;

#### Requirements

- Possess technical expertise in Education, Health and/or Livelihoods;
- Demonstrated experience writing winning proposals for institutional and bi-lateral donors such as UN, DFID, USAID, and EC;
- Experience with commercial funding opportunities;
- Fluent in English required;
- Ability to manage and prioritize multiple concurrent initiatives all within schedule;
- Excellent oral and written communication skills;
- Proficiency in using MS Word, Excel, and PowerPoint;
- Excellent organizational skills with a willingness to assume responsibilities and take initiative; ability to be a team player.

#### **Proposal submission and selection process**

CVs of the individual should be included as an annex to the proposal.

The proposal should be a maximum of 20 pages (excluding Annex) and should include the following:

- Understanding of the study in line with the requirements; Detailed approach and methodology; Work plan, and information about previous similar work experience in last five (5) years
  - The proposal will be evaluated based on the following criteria:
  - Approach and Methodology including the understanding of the assignment.
    - Qualification of individual/key expert.
    - Relevant record of accomplishment.
    - Familiarity of commercial contract of UN, DFID and USAID.
  - Detailed costing for the work.

#### Payment

The individual will be paid through A/C payee Cheque/online bank transfer in the name of the bid winner (individual). Applicable tax and VAT will be deducted at source during the payment made. Please mention the bank information in your proposal as appropriate. Payment will be processed only based on the satisfaction of the final proposal work done. Mode of payment will be paid after submission of Draft Techncial Proposal as 50% (1st installment), 2nd installment 50% will be paid after submission of the Final Techncial Proposal incorporating comments from the VSO team.

#### **Policy and practice**

Any document, information or data entrusted to or produced by VSO in connection with this agreement shall remain confidential and cannot be used by the service provider for any other purpose. This ToR will be followed by VSO corruption policy, data protection policy and child protection policy which will incorporate in detail in the final agreement. This provision shall remain valid even after the completion of this assignment.

#### Termination

Either of the parties possesses the right to terminate the contract giving one-week notice, paying for all deliverables completed at the time of termination, and a pro-rata share of any deliverable in progress of this contract.
