1. Background

Youth For Change Bangladesh Foundation (YFC-BD) is a youth-led, nationwide, non-profit and non-governmental organization working to empower children, adolescents, and young people in Bangladesh, with a strong focus on women and marginalized groups. Established in 2018, YFCBD emerged from a global youth movement on ending child marriage and harmful practices and has since evolved into an independent organization registered with the Registrar of Joint Stock Companies and Firms (RJSC) under Registration No. S-13770, and the NGO Affairs Bureau (NGOAB) under Registration No. 3444. YFCBD works across a wide range of thematic areas including gender equality, sexual and reproductive health and rights (SRHR), climate action, disaster risk reduction, youth leadership, digital safety, and policy advocacy. The organization has led and implemented major national and district-level initiatives such as the Y-Moves project on SRHR and GBV, Safe Digital Space for Girls and Youth (SDSGY), Dhaka Girls Empowerment, and in 2025 “Empower Change: Creating Safe Spaces and Advancing Gender Equality” project across Dhaka, Rangpur, Khulna, and Barisal. YFCBD also convenes and leads youth coalitions such as the Bangladesh Youth Coalition (BYC), a platform of 100+ youth-led and youth-focused organizations advancing youth voices in national policy dialogue.

- Submission of EOI and enlistment document doesn't establish right to get confirmed enlistment at Youth For Change Bangladesh Foundation. Received applications will be reviewed thoroughly and shortlisted vendor and consultant will be selected for enlistment.
- Youth For Change Bangladesh Foundation may seek for additional documents (as applicable/necessary) from the vendor/consultant during the enlistment process.
- Only vendors/consultants who will be selected for enlistment will receive an official notification through their submitted email address afterwards from Youth For Change Bangladesh Foundation authorized person.
- This process is only to collect the available vendor and consultant information for our database. All interested participants all over Bangladesh who have valid business documents/authorization as listed below can apply for enlistment.
- Youth For Change Bangladesh Foundation will check the reference of clients/contacts submitted by the vendor/consultant, as necessary and may visit vendor's office for further verification.
- Enlisted firm(s)/supplier(s) must follow the legal laws, labour laws and child labour laws of the country.
- The enlisted vendors shall have to comply non-staff code of conduct of Youth For Change Bangladesh Foundation. Compliance with these will be built in the subsequent award of enlistment.
- All vendor and consultant applying for enlistment must comply with Youth For Change Bangladesh Foundation Vendor Disclosure Agreement/suppliers questionnaire (will be shared to the shortlisted vendors afterwards).
